Point-of-Sale / Ability Integrated Scale

Application: This is a Point of Sale system used in general purpose weighing for direct sale.

Identification: The certificate number is continuously displayed on the screen. By pressing the certificate number a drop box will drop down displaying all of the marking requirements.

Sealing: All adjustments affecting the metrological integrity of the system are made through the NTEP approved scale.

<u>Operation</u>: The system is configured with a training mode. When inspecting and testing, the inspector must have the store personnel place the POS into the training mode.

<u>Test Conditions</u>: The emphasis of the evaluation was on device design, operation, interaction with the scale, and receipt format. Several transactions were conducted to verify weight operations, price computations, tare capabilities, multiple pound/item pricing and member discount programs. POS software was interfaced with a CAS USA Bench Scale, NTEP CC-92-174.
